Visa Fixed Acquirer Network Fee (FANF)

What is FANF?

Visa imposes this fee on all businesses accepting Visa cards, regardless of processing method. The cost of this fee is calculated based on a number of different factors, including sales volume, business location, and processing methods. The primary differentiator is whether a merchant is processing card present (CP) or card not present (CNP) transactions. If a merchant is processing both CP and CNP transactions both fees may apply. The charts and information below explain how this fee is allocated.

Card Present Processing

If your business accepts card present (CP) transactions, Visa assesses the amount of FANF you're charged on two factors: the number of business locations you own and whether you are deemed a high-volume business.

If your business accepts card not present (CNP) transactions, Visa assesses the amount of FANF you are assessed is based on your monthly Visa processing volume.
